




This collection of original essays takes a long view of the past century of women's political engagement to gauge how much women have achieved in the political arena.




Counting Women's Ballots:


Counting Women's Ballots employs new data and novel methods to provide insights to whether, how, and with what consequences women voted in the elections after suffrage.


Why They Marched:


