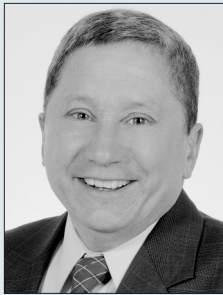

The Rhode Island Bar Foundation Fellows Annual Meeting is held in conjunction with the Rhode Island Bar Association Annual Meeting. President Michael A. St. Pierre and the Board of Directors are pleased to welcome and thank the Foundation Fellows who, through their professional, public and private careers, have demonstrated outstanding dedication to the welfare of the community and to the objectives of the Foundation. During the luncheon we recognize the recipient organizations of Interest on Lawyers Trust Account (IOLTA) grants. \$393,109 was granted this calendar year for the provision of legal services and the administration of justice in Rhode Island.

Recipients of the Thomas F. Black, Jr., Memorial Law School Scholarship are introduced. Again this year, with the continued generosity of The Horace A. Kimball and S. Ella Kimball Foundation and The Champlin Foundation, we were able to grant two \$20,000 Thomas F. Law students are selected for this award based on their outstanding record and interest in pursuing a career in public service. 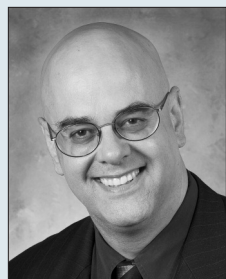

In 2014 he was also named to the "Top 100 Thought Leaders in Trustworthy Business" (trustacrossamerica.com). Marshall is also an award-winning stage director, and for 20 years served as the artistic director for The American Century Theater, a professional non-profit theater company dedicated to producing classic American plays. He lives in Alexandria, Virginia with his wife and business partner, Grace Marshall, their son Grant, and their Jack Russell Terrier, Rugby. Like many who are interested in the nature of good, evil, justice, and chaos, Marshall is a lifetime fan of the Boston Red Sox.
