#### Who We Are

### What is Continuing Legal Education (CLE)?

CLE consists of professional education for attorneys that takes place after their initial admission to the bar. These programs extend the practicing attorney's knowledge beyond what law school offers and keep them up-to-date with relevant changes in the law.

#### What We Do

The RI Bar is Rhode Island's premier provider of legal education. We collaborate with the CLE Committee and Annual Meeting Planning Committee to offer over 80 programs annually, including free CLEs through committees and our Aon-sponsored ethics seminar. The CLE Committee helps plan our annual CLE seminars, while the Annual Meeting Planning Committee develops two days of programming for the Annual Meeting.

#### **RI MCLE Requirements**

**Note:** The RI MCLE and Supreme Court handle all CLE requirements and credit filings. We supply the programming to help you meet those requirements.

The RI Supreme Court requires attorneys practicing in RI to complete 10 hours of CLE in each MCLE reporting year, inclusive of at least two (2) legal ethics credits. Starting July 1, 2025, attorneys will also be required to obtain one (1) credit hour in the area of diversity, equity, and inclusion (DEI). Additionally, RI new admittees must complete the RI Bridge the Gap course within the first full MCLE reporting year after being admitted. The reporting year is July 1-June 30. #### **Easiest Ways to Obtain Credits**
